Executive summary

The NGO Committee on Financing for Development (NGO Committee), created in 2004 as a substantive committee of the Conference of NGOs in Consultative Relationship with the UN, facilitates NGO advocacy on Financing for Development at the at the United Nations in New York.

Mission and Purpose of the NGO Committee:

The NGO Committee supports the goal to "end poverty and hunger and to achieve sustainable development in its three dimensions through promoting inclusive economic growth, protecting the environment, and promoting social inclusion," as outlined in the Addis Ababa Action Agenda and the Monterrey Consensus. It offers a venue for both new and established non-governmental organizations (NGOs) to advocate to further the commitments of the Monterrey Consensus, the Doha Declaration, and the Addis Ababa Action Agenda as well as to learn, discuss, and contribute to the plans, activities, and initiatives pertaining to financing for development discussions at the United Nations in partnership with different stakeholders within the UN system.

As in the previous four years, the executive committee developed a strategic plan with Objectives and SMART Goals and measured its progress against these Goals. A summary of its activities for the current membership cycle is included below:

- Elected a new slate of executive committee members at its annual meeting held on July 7, 2023.
- Held nine monthly meetings which included invited speakers as well as education sessions conducted by members.
- Organized ten substantive sessions (side events, orientation sessions, parallel events, and consultation).
- Held a virtual breakfast consultation with the UN Member States for the seventh consecutive year in preparation for the FfD Forum.
- Conducted an annual orientation session on Financing for Development.
- Conducted two Mission visits. Additional visits are being organized.
- Submitted a written response to the Financing for Sustainable Development Report (FSDR) for the sixth consecutive year.
- Provided direct input to the FfD Forum outcome document in the drafting stages.
- Delivered six interventions at the 2024 FfD Forum.
- Updated the consolidated advocacy statement and reflected those points in interventions made at the UN by members, presentations by the Chair, and visits with Permanent Missions.
- Continued strong collaboration with other NGO Committees.
- Working Groups held regular meetings and provided support for drafting input to the 2024 FSDR, organizing side events, updating the advocacy statement, and participating in Mission visits.
- Staff member(s) from FSDO provided briefings at 8 out of the nine monthly meetings.

Background details on the NGO Committee

A new Executive Committee (EC) was elected at the Committee's Annual Meeting held on July 7, 2023.

1. The leadership of the NGO Committee:

2. Aims and objectives of the Committee:

- The NGO Committee aims to "confront the challenges of financing for development" by staying engaged as advocates for the Addis Ababa Action Agenda's "action areas." Those actions include Domestic public resources, domestic and international private business, and finance, international development cooperation, international trade as an engine for development, Debt, and debt sustainability, addressing systemic issues, and Science, technology, innovation, and capacity-building.
- The NGO Committee works to strengthen consultative relationships with the Financing for Sustainable Development Office of the United Nations Secretariat. The NGO Committee reviews the work of the Economic and Social Council of the United Nations (ECOSOC) and various United Nations Commissions from the perspective of integrating issues related to Financing for Development into the work of these bodies.
- **3. Membership period**: The membership cycle of the Committee is from September 1 to August 31 of next year. Annual Membership due is \$40 payable by Zelle or by check.
- **4. Annual Meetings**: The Committee has been holding its annual meetings in June or July at which the Chair presents and annual report and the treasurer presents the annual financial report.
- **5. Monthly meetings:** Monthly meetings are held on the first Wednesday of the month from 1-3 pm, except in cases of unavoidable conflicts for more than fifty percent of the EC members.

6. United Nations (and civil society) entities the Committee consults, works with, and involves in its work:

The Committee engages actively with the UN Financing for Sustainable Development Office, the International Labour Organisation New York office, and the UN Member States. At its side events, breakfast consultations, and monthly meetings, the Committee makes concerted efforts to include speakers from the UNFSDO, the International Monetary Fund, the World Bank, the UN Member States, and relevant UN agencies. In 2024, the Committee began engaging with UNHCR's New York office and UNICEF. The Committee, as a founding member of the Addis Ababa Coordinating Group, the coordinating body of the Civil Society

Financing for Development Mechanism (previously Group), continues to participate in its work. The Committee engages actively in CoNGO initiatives and makes substantive contributions to CoNGO programs when invited to do so.

7. Additional details on the Committee's activities during this membership cycle are as follows:

- Held ten monthly meetings so far, seven of them in a hybrid (virtual and in-person)
 format and three in a fully virtual format. The in-person components of the hybrid
 meetings were held either at the Bahai International Community Conference Room or
 at the World Vision conference room.
- Maintained a strong relationship with the UN Financing for Sustainable Development Office.
- Continued to strengthen the Committee's joint advocacy efforts with the NGO Coalition
 to End Violence and Harassment in the World of Work (composed of four CoNGO
 Committees NGO Committee on FfD, NGO Committee on CSW (NY), NGO Committee
 on Migration, and NGO Committee on Social Development in partnership with the NGO
 Committee to Stop Trafficking in Persons). AThomas serves as the Convener of the
 Coalition. This coalition is a good example of the Committee's interest and intent to
 collaborate across aisles and outside silos to advocate common priorities.
- Organized (co-organized in some cases) 8 excellent panel discussions (5 side events and three parallel events), annual orientation on FfD, and annual virtual breakfast briefing and consultation with the UN Member States. The panel discussions were held on the sidelines of the ECOSOC Partnership Forum, the Commission on Social Development. the Commission on the Status of Women, and the ECOSOC FfD Forum Follow-up.
- Submitted a written response to the draft outline of the 2024 Financing for Sustainable
 Development Report, for the sixth consecutive year, through the joint efforts of the
 three working groups. The submission is posted to the UNDESA website and can be
 accessed here.
- Updated the Committee's advocacy priorities. The advocacy priorities can be accessed here
- Provided direct input to the 2024 FfD Forum outcome document through channels that the Committee already established through its Mission visits and virtual consultations.
- The Chair represented the Committee at 10 external events (speaker, moderator, guest, and contributor)
- The Chair served on the advisory group for the ECOSOC Partnership Form. She was nominated by the Conference of NGOs (& the President of CoNGO) to serve in this role.
- Several members conducted monthly education sessions during the monthly meetings. wherein they summarized and facilitated discussions on articles and reports of significance to the Committee's work. This also offered the members an opportunity to speak about the work of her/his organization.

Summary of the NGO Committee's activities from July 8, 2023- May 23, 2024

1. Executive Committee's work

The monthly meetings of the EC were held on the third Tuesday of the month from 3:00-4:00 pm via Zoom but were adjusted on occasions due to schedule conflicts for members. The Chair developed the agenda and maintained Google meeting folders for the EC meetings with editing privileges given to all EC members. The secretary drafted the minutes and action items of the meetings. The EC conducted its work in between meetings over email and WhatsApp Group. The Chair also held one-on-one meetings with the executive members at the beginning of the membership and during the year if needed, to provide guidance, discuss the scope of their respective roles, and respond to questions.

An annual evaluation will be disseminated to all members before the annual meeting to be held on July 18. The purpose of the survey is to receive membership feedback on the Committee's activities, to be reviewed by the EC at its annual retreat.

The annual Retreat of the EC will be held in person on August 30 from 10 am -4:00 pm in a hybrid format. The purpose of the retreat is to develop a road map for the Committee's work in the upcoming membership cycle.

2. Objectives and SMART Goals

As in the previous year, the Chair drafted a strategic plan for the Committee which was reviewed by the executive committee and approved at the October 4 meeting of the NGO Committee. The strategic plan can be accessed at this link. The plan lists fifteen objectives and nineteen SMART Goals for the 2023-2024 cycle. While cognizant of the challenges to accomplish objectives and SMART Goals as envisaged, the EC developed these measures to ensure the Committee had a roadmap for its work and with the view to tracking its performance. The EC also invited working group leads to develop a strategy and SMART Goals for their work ahead.

3. Working Groups

The NGO Committee has three working Groups focusing on Social Protection, Financial and Digital Inclusion, and Climate Finance. The scope of work of each of the working groups can be accessed on the Committee's website at this link.

All three working groups conducted their meetings over the Committee's Zoom account. During the course of the year, working groups focused on developing their respective inputs to the 2024 Financing for Sustainable Development Report (FSDR) outline, preparing for a side event during the FfD Forum, and supporting Committee-wide efforts such as Mission visits.

Reports from the three working groups are included below:

• Social Protection Working Group:

The Social Protection Working Group (SPWG) plays a vital role within the NGO Committee on Financing for Development. Its mission is to champion the commitment to "Leave No One Behind" (LNOB) as we work together to achieve the Sustainable Development Goals (SDGs) outlined in Agenda 2030. LNOB serves as the overarching aim, emphasizing inclusivity and equity. The Addis Ababa Action Agenda (AAAA), informed by previous Financing for Development conferences and the Paris Climate Agreement, provides the policy framework for implementing Agenda 2030. Within the AAAA, countries have embraced a new social compact, focusing on supporting vulnerable populations through social protection systems, including social protection floors.

The SPWG's core activities include monthly meetings, ad hoc sessions for event planning, and drafting written statements. During these gatherings, the group reviews essential U.N. documents, relevant articles, and databases. Notably, the SPWG contributed input to the Committee's 2024 FSDR submission to the Inter-Agency Task Force (IATF) on Financing for Development. This year, the SPWG organized a side event at the FfD Forum titled "Global Accelerator on Jobs and Social Protection for Just Transitions and its Implementation." Additionally, they engaged with FfD committee members in Washington, D.C., supported interventions at the FfD Forum, and highlighted how worker cooperatives can enhance social protection during the Committee's monthly meeting. Looking ahead, the SPWG aims to expand its membership and collaborate with other committees and NGOs. A priority area involves advocating for a deeper understanding of the impact of austerity measures and debt

on social protection programs. Furthermore, the group is co-organizing a side event during the Summit of the Future in September.

By championing social protection, the SPWG contributes significantly to the broader goal of leaving no one behind in our pursuit of sustainable development.

• Financial and Digital Inclusion Working Group:

The Financial and Digital Inclusion Working Group (F&DIWG) is an essential component of the NGO FfD Committee and is critical in advocating for the well-being of marginalized and vulnerable communities facing deep disparities in access to inclusive finance and digital financial products and services. Focused on leaving no one behind in a highly digitized age and acknowledging that access to financial products and services is a human right, this Working Group sets priorities for educating stakeholders on inclusion strategies that would promise transparent, safe, accessible, and affordable digital financial services for people living in poverty, especially women who suffer the greatest poverty deficits as a consequence of financial and digital exclusion. Committee members are continuously educated on emerging issues to facilitate their active participation in relevant FfD sessions and to grow their capacity to address these issues in written priority statements.

To meet its strategic goals, the F&DIWG meets at least once a month, with additional ad hoc meetings for event planning, and preparing written statements or proposals. meetings included reviews of key U.N. documents as well as articles and databases relevant to its work. Among its activities this year, the Working Group drafted an input for the Committee's submission to the 2024 FSDR of the Inter-Agency Task Force (IATF) on Financing for Development; assisted in planning for the Committee's side event at the 2024 ECOSOC Partnership Forum ("Shaping a Resilient Future for People and the Planet"); organized a side event for the 2024 ECOSOC Financing for Development Forum Follow-up. ("Investing in Safe and Inclusive Digital Public Infrastructure"); supported with two interventions at the FfD Forum; submitted a proposal for the IMF/World Bank Spring 2024 meetings and joined other FfD committee members at the meetings in Washington, D.C.; developed and circulated a survey to NGO Committee on FfD member organization's engagement on financial inclusion. The FDIWG is currently drafting a proposal for submission to Financial Inclusion Week, to be held in October of this year. Expanding membership and liaising with other committees and NGOs is a key goal for the upcoming year, to broaden the working group's reach and areas of expertise.

• Climate Finance Working Group:

The Climate Finance Working Group (CFWG) is made up of members from the NGO Committee on Financing for Development. CFWG meets monthly to discuss climate finance priorities on behalf of the NGO Committee on Financing for Development and hosts an annual side event at the United Nations Financing for Development Forum. The Working Group contributed to the Committee's input to the 2024 Financing for Sustainable Report. It also updated the annual climate-specific advocacy priorities of the Committee.

Most recently, with COP28 agreeing to establish a loss and damage fund for vulnerable countries, CFWG also renewed its focus on the topic. CFWG organized the "Reframing

Climate Finance: Navigating Loss and Damage" panel discussion as a side event at the 2024 ECOSOC Financing for Development Forum Follow-up.

6. Monthly Committee Meetings

The Committee took a summer recess in August and reconvened in September. The meetings are held on the first Wednesday of the month from 1-3 pm in a hybrid format, virtually via Zoom and in-person at the Bahai International Community Conference Room or the World Vision Conference Room or held virtually via Zoom, when a meeting room was unavailable.
